1. The provision is for expenditure on Scheme for strengthening of institutions. This focuses on putting in place new institutional mechanisms and strengthening of existing institution for human resouces development in food processing sector. It will cover components like (i) Strengthening of Paddy Processing Research Centre, Thanjavur which is to be developed into a national-level institute, (ii) Strengthening of State Nodal Agencies, (iii) Promotion of Information Technology and (iv) Meeting the expenditure on establishment of the Secretariat of the Ministry and Wine Board & Meat and Poultry Processing Board.

2. The provision is for providing Assistance in the shape of grants-in-aid and other charges etc. for Infrastructure Development for Mega Food Parks, Packaging Centre, Modernization of Abattoirs,

Integrated Cold Chain Facilities, Irradiation Facilities and Value Added Centres.

3. The provision is made for the expenditure on the establishment of Rice Milling Cell for providing assistance in the shape of grants-in-aid and other charges etc. for (i) Scheme for Technology Upgradation, Establishment and modernization of Food Processing Industries, (ii) Scheme for Upgradation of Quality of Street Food, (iii) Scheme for Human Resource Development, (iv) Scheme for Quality Assurance, Codex Standards, Research and Development and other Promotional Activities, (v) Setting up of National Institute of Food Technology Entrepreneurship and Management (NIFTEM) at Kundli (Haryana).

4. Lump Sum Provision has been kept for projects/schemes for the benefit of North Eastern States including Sikkim.
