1. **Central Reserve Police Force:** The Force assists the State Governments in the maintenance of law and order and performs various internal security duties when requisitioned by the States. The Force is also used in arranging relief at the time of natural calamities, etc.

2. **National Security Guard:** NSG is a specialized force for combating terrorism in all forms. With this background, NSG was raised in 1984 as a Federal force to tackle specific situations requiring special skills and thus counter the increasing menace of terrorism in all forms.

3. **Border Security Force:** This Force, apart from its normal deployment for keeping vigil along the actual line of control in Jammu and Kashmir, the Indo-Pak borders in Punjab, Rajasthan and Gujarat, Indo-Bangladesh and Indo-Myanmar borders, provides effective assistance to the local administration in maintenance of law and order. It also promotes a sense of security amongst the border/local population and prevents border crimes and infiltration across the international borders/Line of Control.

4. **Indo-Tibetan Border Police:** The ITBP is for policing the Indo-Tibetan Border in U.P., Himachal Pradesh, Jammu & Kashmir and Arunachal Pradesh sectors.

5. **Central Industrial Security Force:** CISF assists in the protection of the properties of public sector undertakings and other Central/State Government agencies.

6. **Assam Rifles:** Assam Rifles is the oldest para-military force in the country. Bulk of the Force operates in North East under the operational control of the Army.

7. **Sashastra Seema Bal:** This is another Border Guarding Force detailed on Indo-Nepal Border as well as Indo-Bhutan from Uttarakhand to Sikkim. The force is also detailed for internal security duties in North East, J & K and Union Territory of Chandigarh, etc.

8. **Education, Training and Research:** This covers expenditure on the Sardar Vallabhbhai Patel National Police Academy, Hyderabad; Central Detective Training School; National Institute of Criminology and Forensic Science; Bureau of Police Research and Development. This also includes provision for North East Police Academy for imparting training to the Police personnel of the North East Region. The provision is also for schemes of BPR&D, viz., (a) Training Interventions, (b) R & D Projects for better efficiency and increased out reach to public and police, etc. and also for prisons to improve training skills, infrastructure, scientific evaluations etc. This also includes expenditure on establishment of Central Police Training College and setting up of 6 new Zonal Branches cum Central Detective Training Schools (CDTS) and upgrading the existing 3 CDTS to cater to the training and research needs of police and prisons for each of the respective zones. The provision is also for strengthening the law enforcement response to trafficking in persons through training and establishment of Anti Human Trafficking Unit.

9. **Criminal Investigation and Vigilance:** This covers expenditure on Central Forensic Science Laboratories and Government Examiner of Questioned Documents. The provision is also for modernization of Central Forensic Science Laboratories and Government Examiners of Questioned Documents with emphasis on human resources development and Research and Development schemes, establishment of Regional Forensic Laboratories and DNA Centres.

10. **Inter-State Police Wireless Scheme:** Apart from transmitting messages to and from States, this scheme aims at modernizing the system of introducing sophisticated equipment using microprocessor controlled technology.

11, 30 & 33.01. **Special Police:** This includes charges to be reimbursed to State Governments for expenditure incurred for maintenance of border check-posts, etc.

12, 31.01 & 32. **Modernisation of Police Force:** Under this scheme, assistance is provided in cash and kind to the State Governments/Union Territories in the form of 100 % grants-in-aid to be utilized for expenditure of non-recurring nature on purchase of vehicles, wireless equipments, computer and other sophisticated equipments and for development of Critical infrastructure in extremist affected areas, setting up of Crime & Criminal Tracking Network and Systems and for establishment of counter insurgency and anti-terrorist schools.

13, 20 & 27. **Delhi Police:** Delhi police is charged with the responsibility of maintaining and enforcing law and order in Delhi. Its responsibility also extend to traffic management, providing V.I.P. Security, licensing and foreigners registration, etc. Law and order in Delhi is a reserve subject, which has been retained with the Central Government. Expenditure of Delhi Police, which was earlier being met by the Government of National Capital Territory of Delhi, is being borne by the Central Government, effective from August 1, 1996.

The provision on Capital account is for expenditure of installation of traffic signals, etc. in the territory of Delhi.

14, 26, 28, 29, 31.02, 31.06, 40 & 41. **Other Schemes:** This includes expenditure on National Crime Records Bureau and other grants and loans in kind to the State Governments for deployment of Battalions and raising India Reserve Battalions, Special Central Assistance to the State Governments for security related expenditure, modernization of State Police forces in North Eastern Region and coastal surveillance, etc.

15 & 34. **Construction of Residential Accommodation for Police:** The provision has been made for construction of accommodation for Central Police Organizations (Assam Riffle, CRPF, BSF, ITBP, CISF, NPA, SSB, etc.) and Delhi Police.

16 & 35. **Construction of buildings for Police:** This covers expenditure on construction of border outposts, building Central Police Organizations (CRPF, CISF, ITBP, Assam Riffle, BSF, SSB, etc.) and Delhi Police.

17, 18, 36.01 & 36.02. **Indo-Bangladesh Border Works:** Erection of Barbed Wire Fencing and construction of roads on the Indo-Bangladesh Borders are intended to check illegal immigration.

19 & 36.03. **Indo-Pak Border Works:** Under this Scheme provision has been made to check illegal infiltration and inflow of arms and ammunition from across the Indo-Pak Border.

21, 36.04, 36.05, 36.06, 37, 38, 39 & 40. **Hi-Tech Surveillance & creation of infrastructure for Borders and Coastal Security:** The provision is for maintenance of Indo-Bangladesh and Indo-Pak Border works and also includes provision for purchase of aircraft/river boats by BSF. This includes provision for management of other borders, creation of infrastructure, Indo-China Border, Indo-Myanmar Border, Indo-Nepal Border & Indo-Bhutan Border and Induction of hi-tech surveillance on Indo-Pak border, Indo-Bangladesh Border and other borders as also construction of Border Out Posts by various CPMFs.

22 & 31.03. **Critical Infrastructure in Left Wing Extremist affected areas:** The provision is for supplementing the efforts and resources of the extremism affected States in the areas of security development to cover infrastructure gaps.

23 & 31.04. **Crime and Criminal Tracking Network and Systems:** The objectives of the schemes are automation of Police Stations, reduction in manual and redundant record keeping, retrieval of information, sharing of information etc.

24 & 31.05. **Assistance to counter insurgency & anti-terrorist schools:** The provision is for providing assistance to State Governments for establishment of counter insurgency & anti-terrorist Schools for training of Police personnel.

25 & 33.02. **Setting up of Integrated Check Posts:** The provision is for setting up of Integrated Check Posts at Indo-Nepal and Indo-Bhutan Borders to stop illegal immigration.
